Mark is 4Sight's national sector lead for Renewable Energy, Manager of the company's Wellington office, an RMA Planner with over 30 years' experience, and an experienced hearings commissioner. He is a current director of the New Zealand Wind Energy Association (NZWEA) and obtained resource consent for Aotearoa's first commercial wind farm (Haunui) in 1995. He has maintained a keen interest in renewable energy since that time. In 2004 Mark was awarded a Winston Churchill Fellowship to enable study of other countries' planning systems in relation to wind energy. With regard to 4Sight's renewable energy projects, he maintains an overview – helping to pull together skills across disciplines that include property, RMA planning, community and iwi engagement, ecology, landscape assessment, and contaminated land management.

Beth Wotherspoon**Mercury**

Beth is the Head of Resources & Stakeholders at Mercury NZ Ltd and responsible for maintaining and enhancing fuel supply for the company across all fuel types.

With an engineering consultancy background from the UK and NZ Beth started work for Mercury in 2011 as a project manager on the Waikato hydro scheme. She had no idea this would lead to a decade of opportunities and personal growth, resulting in this exciting role contributing to NZ's decarbonisation goal and working with the leading wind energy development team in the country.

Chris Rendall**Department of Conservation**

For the last 11 years I have worked for the Department of Conservation (DOC). For three years in Taranaki as a Community Ranger focussed on resource management and land management. This included engagement in oil and gas and offshore ironsand. I then moved to a Senior National Advisor RMA role, initially focussing on resources to support our rangers engage in Resource Management Act (RMA) processes, supporting the Minister of Conservation fulfil functions under the RMA and some engagement in specific processes, for example the Chatham Rock Phosphate marine consent application. I have also contributed to national direction development and review under the RMA, legislation development including the COVID-19 Recovery (Fast-track Consenting) Act 2020, and specific topics including mining on conservation land.

For the 22FY I have been working on a range of projects, including DOC's approach to engagement in renewable energy proposals, continued refinement of the DOC RMA engagement system & resource management reforms. Recent renewables engagement includes onshore and offshore windfarm, hydro reconsementing and solar farm discussions. This has included NZ scale site selection commentary and responding to specific NZWEA enquiries.

Stephen Fuller**Boffa Miskell**

Stephen is a Principal Ecologist and Partner with Boffa Miskell Limited. Since 2003 he has prepared the ecological assessments for twelve commercial wind farms of which ten were consented and six have been built.

And he is currently involved in the scoping studies, baseline monitoring and preliminary assessments for five new projects.

In each case the risk to avifauna of collision or displacement has been a key consideration during consenting, as were pre and post construction avifauna monitoring.

Stephen first presented to an NZWEA conference in 2004. This talk is an update on the last 18 years of study, and gives his thoughts on the future of avifauna assessment in New Zealand.

Liz Moncrieff**Ministry for the Environment**

Liz Moncrieff has worked in the resource management field for over 20 years, including working for Wellington City Council in their District Plan Policy Team (10 years+) and at a private consultancy firm for 3 years.

Liz started her career as an analyst at MfE back in the late 1990s, and returned to MfE in 2016 where she led the development of the National Planning Standards and the National Policy Statement – Urban Development 2020. She recently moved into the role of Director, Resource Management Reform.

Niels Steenberg**Siemens Gamesa Renewable Energy**

Niels Steenberg originates from Denmark, but he has spent close to 20 years living in Asia Pacific. He joined the Wind Power industry in 2011 and has been leading Siemens Gamesa's Offshore activities in Asia Pacific since the establishment of its regional headquarters in Taipei, in December 2017.

Prior to that, he was heading onshore sales in the region for four year. His aim is to establish a strong and sustainable footprint for Siemens

Gamesa in Asia Pacific, in order to support the development of the offshore industry with competitive product solutions, fit for the region's specific needs

Anne Probert is the GM for Venture Taranaki's (VT) Regional Strategy and Sectors workstream, and a regional development specialist with over 25 years in the industry.

Her leadership includes the implementation phase of the Taranaki 2050 roadmap as the Taranaki region moves towards a high value, low emissions future; energy transition opportunities such as the extension of oil and gas sectoral strengths into offshore wind and hydrogen; and building on Taranaki's untapped strengths of in food and fibre with a series of (just launched) new commercial ventures and potential pilots.

Ryan McDonald is Head of New Business at Hiringa Energy, a roll which he has held since 2019. Prior to working for Hiringa Energy Ryan spent 20 years in engineering consultancy, principally in the energy and resources sector, including over a decade in various general management roles throughout Australasia. At Hiringa Energy Ryan manages the New Business function who's responsibilities include strategic growth, customer engagement, pre contract commercial agreements, government engagement and marketing. Ryan is a chartered engineer with Engineers New Zealand and holds a Bachelor of Technology from Massey University.

Charles Rattray**Copenhagen Offshore Partners**

Charles commenced his professional life at Duntroon in Canberra and achieved the rank of Captain in the Army. This was followed by 15 years in investment banking and finance. He worked on varied opportunities such as mining and minerals in emerging markets, renewable projects (wind and solar), PPPs in Australia and UK and acquiring discounted debt securities during the Global Financial Crisis. In more recent times Charles has held executive level roles in large utilities focused on renewables, new business in energy transition and acquisitions. Most recently Charles was Managing Director of an IPP in Australia with around 500MW of installed capacity and projects at various stages from early development to construction and into operations.

Charles is now CEO of Copenhagen Offshore Partners (Australia) and CEO of Star of the South, on track to become the first commercial offshore wind farm in Australia.

Inna Kulawiec**Vestas**

Inna Kulawiec is the Head of APAC Sales Operation, Value Engineering & KAM at Vestas. Her extensive experience in energy includes her time at PricewaterhouseCoopers in project management and transaction services within the energy and resources portfolio, followed by commercial management with the Australian Energy Market Operator to lead the negotiations of long-term infrastructure agreements as well as procurement and commercial services with Alcoa in their manufacturing facilities. Prior to Vestas, Inna Kulawiec led the City of Yarra's carbon emissions reduction strategy at the Yarra Energy Foundation.

David Weaver**Concept Consulting**

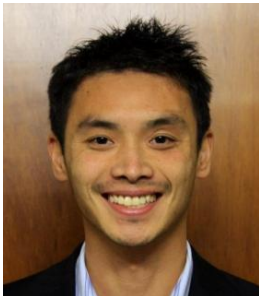
